- Henselstone Trails
  - Efforts continue on Henselstone Trails debris clearing and trail improvements.
  - We are currently replacing the fence on the north side (railroad side) of Henselstone Trails, as well as repairing some washed out drain pipes. We will revisit our project progress at the April 2023 board meeting.
- Community activities for 2022 included a Henselstone Community Yard Sale, a clean-up day at Henselstone Trails, our community clean-up day and pine needle pick-up at the mail boxes.

## New business

- Thanks to Bob Zyniewicz and Matthew Reisinger for collating our community Firewise data from 2022. Their efforts have been recognized by the State and make us eligible for grant money this year to subsidize future cleanup.
- Our chip drop at Henselstone woods greatly aided our trail maintenance efforts this year.
- The federal government has allocated funds for the planning and creation a rail trail from Front Royal to Broadway on the old Norfolk-Southern rail line. No timeline is available for this project at this date.
